



- Cutting sticks of pipe and weld test specimens using a vertical bandsaw
- Cut bevels on plate and pipe coupons using Oxy-Acetylene beveling machines
- Moving equipment and pipe with a forklift
- Organize and sort materials
- Maintain weld shop inventory in warehouse and storage room
- Daily weld shop maintenance including trash removal, mopping, sweeping, swapping out lightbulbs and related
- Monitor and change gas cylinders
- Sanitize PAPr welding hoods
- Conducting COVID-19 screening + monitoring


